Your views are important to us and we will take them on board as we progress our plans in preparation for the formal planning application.

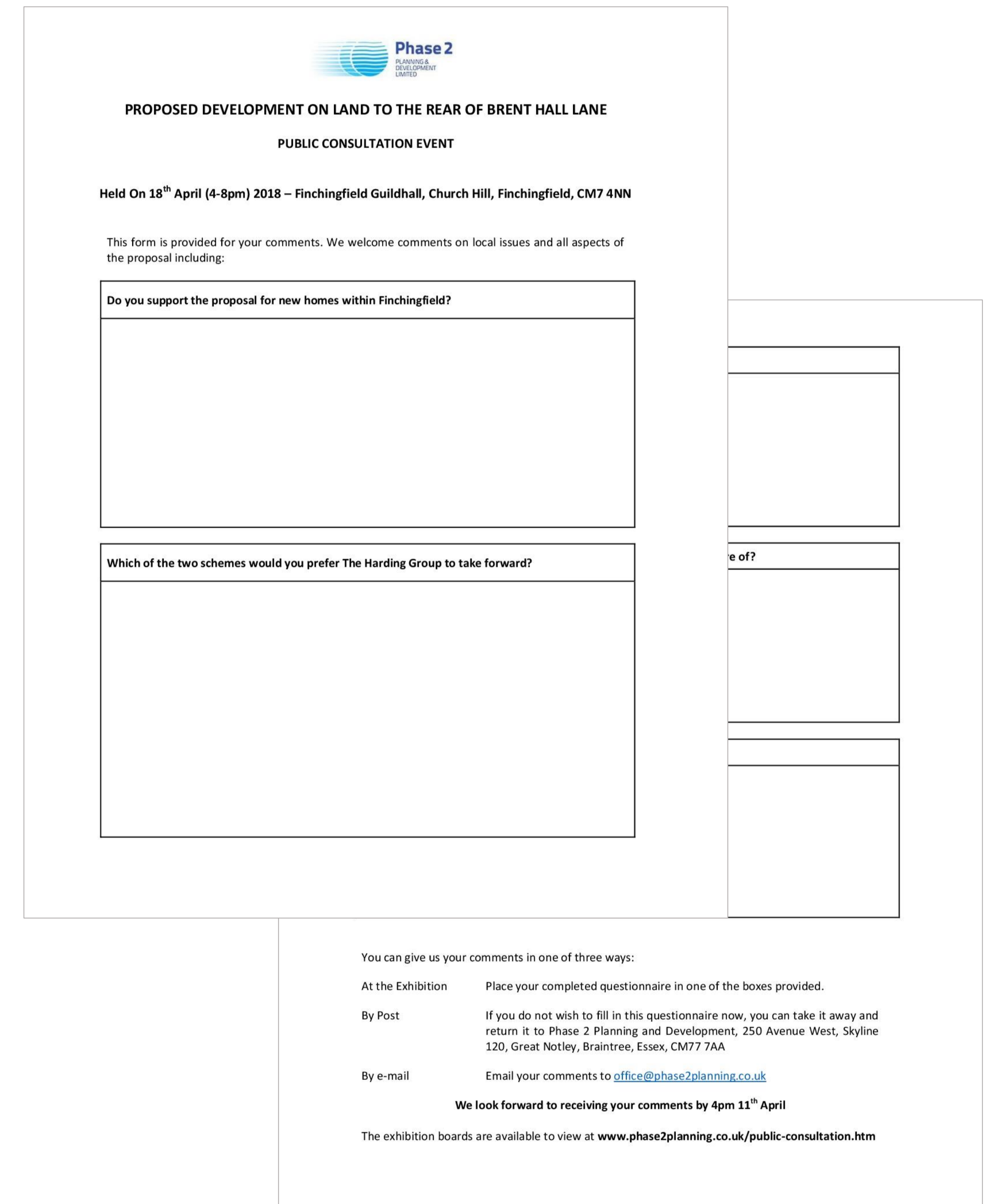
We would therefore be very grateful if you could take the time to complete one of the comments forms provided, and place them in one of the boxes on the tables.
